

Privacy Notice - Data Protection Act 1998

We The Wordsley School are the Data Controller for the purposes of the Data Protection Act. We collect information from you and may receive information about you from your previous school and the Learning Records Service. We hold this personal data and use it to:

- Support your teaching and learning;
- Monitor and report on your progress;
- Provide appropriate pastoral care, and
- Assess how well your school is doing.

This information includes your contact details, national curriculum assessment results, attendance information and personal characteristics such as your ethnic group, special educational needs and any relevant medical information. Where your child has a care plan that has been set up in partnership with Health Services and the school, this may be shared with staff within the school environment to ensure that it is adhered to correctly. It may be held on the Schools computer systems. Attendance information is not collected for pupils under 5 at Early Years Settings or Maintained Schools.

We will not give information about you to anyone outside the school without your consent or where the law allows and a legitimate reason exists.

We are required by law to pass some of your information to the Local Authority (LA) and the Department for Education (DfE)

Once aged 13 or over, we are required by law to pass on certain information to providers of youth support services in your area. This is the local authority support service for young people aged 13 to 19 in England. We must provide both your and your parent's/s' name(s) and address, and any further information relevant to the support services' role. However, if you are over 16, you (or your parent(s)) can ask that no information beyond names, address and your date of birth be passed to the support service. **Please inform the school if you wish to opt-out of this arrangement.** For more information about young peoples' services, please go to the Directgov Young People page at www.direct.gov.uk/en/YoungPeople/index.htm or the LA website.

The school may share personal information on a regular basis with the Local Authority (LA) about children for whom the LA provides services.
